UK ASA AGM - Sat. 28th March 2009

Held at the Leapark Hotel, Bo'ness Road, Grangemouth
The AGM followed that of the B-P Scout Guild (Scotland), Allan Page, as Chairman of the Committee opened the meeting and began by introducing the members of the committee seated at the top table. Printed copies of the Minutes of the 2008 AGM were provided and were accepted and approved by the meeting. The Annual Report was approved and will now be forwarded to the World Bureau. In the absence of Alan Beavis, Treasurer his written report, balance sheets and budgets for 2010 were presented by Willie Taylor and approved by the meeting. A vote of thanks to the officers who have given time and money to running ASA was proposed and fully endorsed by the members present. The membership fee for 2010 is to remain at £4. This year several members of the committee had completed their first 3 year term. For the Baden Powell Guild, Sue Page was standing down, Allan Page had been nominated for a 2nd term to 2 years. For the B-P Scout Guild (Scotland) Willie Taylor and Robert Nicol were nominated for their 1st term of 3 years. For the Central Group, Beryl Aldridge, Brian Staines & Dave Mowbray were all nominated for their 2nd term of 2 years. The meeting voted in favour of accepting all those Nominated for the Committee. Presentations were made at this point to Sue Page for her work as Secretary and Allan Page for his work as Chairman of the ASA Committee. There being no other AGM business the meeting closed at 3.45pm

Annual Report to ISGF World Committee December 2008

The UK Adult Scout Alliance (UKASA) is a 'Member Organization' of the International Scout & Guide Fellowship (ISGF) for the United Kingdom. It is made up of three component organisations:

The B-P Scout Guild (Scotland)
The Baden Powell Guild of Gt. Britain
The Central Group

These organisations are completely independent, but come together as UKASA to form one organisation for membership of the ISGF. Each organisation and the groups within run their own program for supporting local Scouting. Many individual members have developed international contacts around the world.

The revised constitution for UKASA submitted in 2006 was approved by the World Committee during 2008.

The support given by the Guilds and individual members is much varied and ranges from practical support to financial support for Scouting and Guiding and all manner of charitable and community causes.

It is estimated that in excess of 2000 hours and £4000 has been given to support Scouting and Guiding in addition to 1000 hours and £2000 to charitable and community causes. It must be noted that these are probably very low estimates. The activities of UKASA members are scattered across the United Kingdom and because many forms of financial and practical support take place locally by small groups and individuals they are not recorded in such a way that can be collated at a national level. It not considered necessary or desirable to collect and record such detailed information.

Membership numbers have gone down from 245 as at December 2007 to 243 as at December 2008.

Members attended the Grossarl Forum in January 2008. Members also attended the World Conference in Vienna. A member attended the European Region Workshop.

Central Group Meeting

A rather depleted Central Group annual meeting was held on the morning of the UKASA AGM. The 2008 Minutes were handed out and approved. Beryl presented the Annual report. Numbers had remained fairly static. Three members had attended the World Conference in Vienna and Beryl had represented UKASA at the 2nd European Conference in Kutna Hora-Prague. Members had supported Scouting and Guiding locally and taken part in International projects. Some went to the Gilwell Reunion, attended Fellowship Day services and some are booked to go to the Western European Gathering in Dundee this summer. The ISGF Bureau Info is now being distributed to members by post or E-mail.

David Mowbray, Brian Staines and Beryl Aldridge had agreed to be nominated for a further term of 2 years to the UKASA Committee to represent Central Group. Others present at the meeting were asked if they would like to be nominated but they declined. The question was raised as to whether nomination forms should have been sent out to all members prior to the meeting. There is no precedent for this in the CG Terms of Reference but it was agreed that we should do this in future. The meeting agreed that Central Group would be responsible for hosting the 2010 UKASA AGM. Beryl Aldridge.

EUROPE REGION CHALLENGE - Part 2

Now it is time to widen your search and your Guild can find out about the Guilds / Fellowships in another European Country.

1. Identify the European Country that you would like to contact. (Your country's International Secretary or International Adviser could give you a contact address in that country), also look to see if there is a Web site for the Guilds in that country.
2. Correspond with a Guild in the European Country you have chosen. Europe is a large continent with many languages how about learning a few phrases in the language of the country you choose? How about Twinning with another Guild.
3. Share programme ideas and recruitment ideas with the Guild you have contacted
4. Find out what service projects to support Scouting or Guiding, the Guild you have contacted, is planning during the next twelve months – your Guild may be able to help in providing ideas, resources or even “manpower”. Remember that the other Guild may be able to help your Guild with a project.
5. Make a poster showing what you have achieved and display it at the next European Conference in Cyprus in 2010.
6. In your own country find out about another Guild and share programme ideas and if possible visit the Guild or contact the Guild by telephone, text, letters or emails.
7. Find out what service projects to support Scouting or Guiding the Guild, you have contacted, is planning during the next twelve months – your Guild may be able to help in providing ideas, resources or even “manpower”.
8. Record what you have done in a log book
